MINUTES of the Regular Board Meeting of the Board of Directors of the City Development Corporation (CDC) of El Campo, Texas held at the Northside Education Center, 707 Fahrenthold, in the Board Room within said City, at 2:00PM on Monday, September 23, 2024.

- 1. Cuatro Strack called the Regular CDC Meeting to Order at 2:04PM.
- 2. Tommy Hitzfeld led the Pledge of Allegiance, and Anthony Garcia led the Prayer.
- 3. Cuatro Strack confirmed the presence of a quorum of the Board. Board members present were Cuatro Strack, Tommy Hitzfeld, Gary Raybon, Anthony Garcia and Brian Hodges. Also present were Executive Director Carolyn Gibson, City Manager Courtney Sladek, Deputy City Manager Rene Garcia, and Chamber Director Kelly Balthrop.

She noted the invoices/payment for the Site Improvement Grants to El Campo Bowling, Jalapeno's, Gulf Stream Construction, and Hobo Electric, were being verified and checks would be issued when this is complete. She also reported the verification of Job Creation was underway for Gene's Wrecker. No action was necessary.
